General

1. Every guest and every member is subject to the House Rules. In order to ensure a pleasant stay for all visitors the guest/member is obliged to follow any instructions given by staff.
2. Smoking is not permitted anywhere within the facilities.
3. It is strictly forbidden for you to consume any food or drink on the premises that you have brought with you.
4. The use of electronic devices (mobile phones, laptops, smartphones) is prohibited.
5. Gross violation of the behavioural rules on the part of a member/guest will result in immediate cancellation of the membership contract. Furthermore it could lead to the person in question being banned from the premises.
6. If asiaspa GmbH cancels the membership contract for a valid reason as a result of the behaviour of the member, the member is not relieved from paying the remaining membership contributions up until the end of the contract. For any culpably caused damage to machines and furnishings belonging to asiaspa GmbH, the member/guest who caused the damage must be held responsible.
7. asiaspa is not liable for any valuables; this applies to items secured in the lockers, for items that get lost within the facilities and lost property. Any items found in asiaspa will be collected at the close of business and stored under the day they were found. Lost property is kept for 2 months; valuables are kept for 6 months.
8. Reissuing locker keys costs 50.– CHF.
9. Membership can be taken out from the age of 18.

Payment obligations/Putting the membership on hold

1. As a rule, the temporary non-exercise of the membership rights for reasons that exclusively concern the sphere of influence of the member does not release the member from his/her payment obligations. If individual sections of the facilities cannot be used, this does not release the member from his/her payment obligations.
2. The membership may be put on hold so long as it can be proven that the membership cannot be exercised for medical reasons. The member must present asiaspa GmbH with such proof. If these circumstances continue over a long period of time and, with reasonable consideration, the member has no interest in renewing the membership, he/she may cancel the contract at the end of a contractual month without adhering to a period of notice. The same applies to a member who moves house insofar as exercising the rights of membership is unreasonable. The member has to provide proof of such circumstances (max. 6 month).
3. asiaspa GmbH must be notified immediately of any change of name or address.
4. Transferring the rights of membership to another person requires both people to be present so as to sign the transfer agreement.
5. There are no verbal side agreements. All additional arrangements must be made in writing.
6. Switching from a Full-Time membership to a Sunshine or Mid-Week membership is only possible at the end of the contract. Upgrading to a Full-Time membership is possible at the end of every contractual month.

Additional agreements — sauna area

1. You are not guaranteed a place to sit or lie on.
2. Places to sit and lie on may not be reserved. It is forbidden to place bags, towels or other objects on places to sit or lie on for this purpose. If items are found serving this purpose they may be removed by staff.

3. Jumping into the Onsen pool is forbidden. Due to a risk of injury it is strictly forbidden to stand on the edge of the pool.
4. asiaspa GmbH is not liable for any personal injury or damage to property occurring due to the intended pathways not being used. No liability is accepted for everyday dangers.
5. The use of personal infusion essences in the saunas is not permitted. Infusions are carried out exclusively by members of staff. For hygienic reasons it is forbidden to wear bathing costumes in the saunas.
6. asiaspa GmbH accepts no liability for any colouring/bleaching/damage caused to clothing or towels.
7. Within the facilities all guests/members are to behave in way that does not offend any other guests/members.

Additional agreements — fitness area

1. The member is responsible for informing him/herself and ensuring that the requirements of the chosen programme are suitable for his/her physical capabilities. asiaspa GmbH does not accept responsibility for undertaking a general medical suitability check nor the duty to exercise proper care and therefore does not accept any liability for damage to health resulting from physical overexertion, unless this is due to explanations, consultations and a duty to communicate information regarding the use of the equipment being omitted or insufficient and resulting in typical dangers from a medical sports perspective.
2. As long as the highest number of participants is not exceeded, members may take part in any of the fitness classes at any time without the need to prebook.
3. Suitable sport clothes and shoes must be worn.
4. Glass drinking bottles are not allowed in the fitness area.

Additional agreements — hamam area

1. Please make your hamam appointment in good time either online or by telephone. Appointments are obligatory.
2. Our hamam is **not** a textile-free zone. It is obligatory to wear the pestemal (towel). The pestemal may be removed during self-performed body scrubs, cleansing treatments and rasul applications.
3. The hamam is a place of inner and outer purification. We request that you keep conversation to a minimum.
4. We request that you do not visit the Onsen pool or the steam bath for at least one hour after a rasul application so as to allow the minerals to take effect.
5. Please note: we have to charge full price or collect any hamam vouchers for any hamam appointment cancelled less than 24 hours prior to its scheduled time. Appointments booked online cannot be cancelled but they may be rescheduled online up to 24 hours prior to the time of your treatment, subject to availability.
6. Once the hamam vouchers from the voucher booklet have been used up, members receive a 10% discount off the regular hamam treatment prices.

Prices and opening hours are as detailed in the current version of the notice.

Should any condition of this contract become invalid, it shall have no effect on the remaining conditions of the contract.
